**Reserve early!** Reserve campsites and group areas one day to nine months in advance by calling 1-800-452-5687. Campsites are also reservable through [www.oregonstateparks.org](http://www.oregonstateparks.org).

Milo McIver State Park offers seasonal camping and year-round recreation ranging from horseback riding and disc golfing to boating and fishing along the scenic Clackamas River and Estacada Lake.

### Seasonal Camping

(Mid-March–October)

- 44 electrical sites with water
- 9 tent sites with water nearby
- Paved parking, picnic table, and fire ring at all sites
- Hot showers and flush toilets
- 3 group tent camping areas with water, flush toilets, and fire rings
- 3 Hiker/biker camp sites with water, lockers, solar charging station and fire pit.
- RV dump station located just past the registration booth

### Universal Access

Campsite A10 is accessible according to the Americans with Disabilities Act.

### Enjoy the View

Milo McIver features more than 950 acres of lush forest and grassy meadows on natural terraces above the Clackamas River, as well as vistas of three prominent Cascade peaks: Oregon's Mt. Hood and Washington's Mount St. Helens and Mt. Adams. A memorial viewpoint near the entrance honors Milo K. McIver, an Oregon State Highway Commissioner from 1950 to 1962.

### A Day at the Park

Milo McIver State Park has two inviting day-use areas open year-round. The **Riverbend Day-use Area** has rolling grass meadows accented by maple and Douglas-fir trees. Here you will find trails, picnic shelters, restrooms, a 27-hole disc golf course and a primitive boat launch. Picnic tables are located near each of the major parking areas. Picnic shelters for large groups can be reserved in advance, 800-452-5687.

The **Riverside Day-use Area** has picnic tables, a group picnic area, a boating/rafting access ramp, a large parking area and a fish hatchery operated by the Oregon Department of Fish and Wildlife. The hatchery raises and releases more than a million Chinook salmon each year. The group picnic area near the hatchery can accommodate up to 200 people. Seven miles of hiking and horseback trails meander through meadows and forested hillsides.

### Disc Golf Fun

Spend a lazy afternoon playing this popular sport in the park's nationally recognized, year-round, 27-hole disc golf course that weaves over rolling hills and forests along the scenic Clackamas River. The course—located in the Riverbend day-use area—is fun for all levels from beginner to pro. Rent or buy discs at the park office.

### Day-use Parking

Day-use visitors must have a valid parking permit. You can buy a daily permit at the park's entrance booth, or purchase 12- and 24-month permits at [store.oregonstateparks.org](http://store.oregonstateparks.org) and at major park offices, including the Milo McIver office. Your camping receipt serves as a daily parking permit for the days you are registered.

### Play it Safe

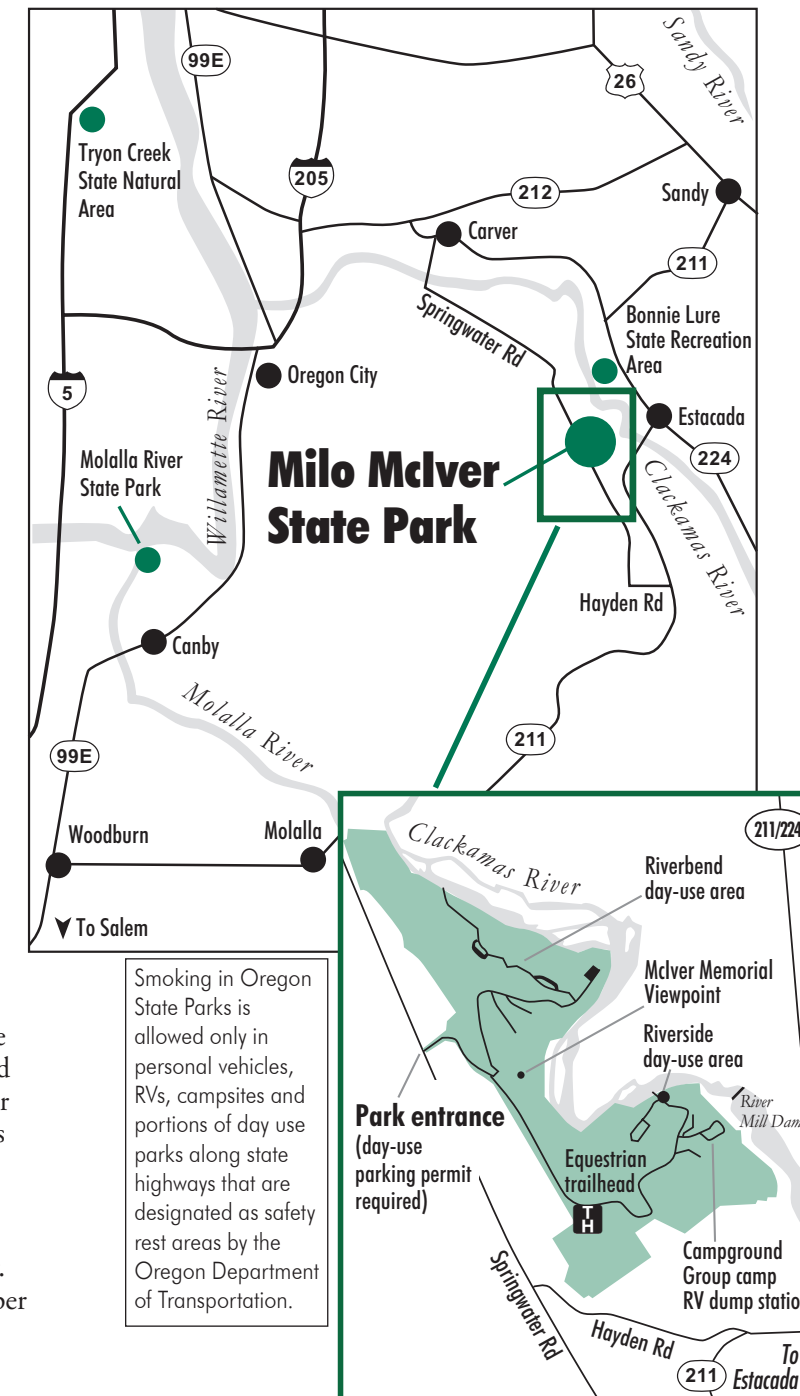
The park has many access points to the Clackamas River. Do not try to navigate the river unless you have the proper equipment and skill. The river current can be swift. Always wear a life jacket.

# Milo McIver

- Campground quiet hours are between 10 p.m. and 7 a.m.
- All vehicles must be parked on pavement.
- Bicycles are permitted on park roads only, but must be ridden with the traffic flow. Riders under age 16 must wear helmets.
- Pets must be physically restrained at all times when not confined in a vehicle or tent. Leashes must be no longer than six feet. All waste must be properly removed. (See our "Pets in Parks" brochure for details.)
- A day-use permit is required to park at Milo McIver unless registered as an overnight camper.

**Check-in** after 4 p.m., **Check-out** by 1 p.m. (14-night stay limit.)
